

SESSION: Survey - Oy Vey : Mitigating "Oy Veys" in LTC Surveys

SUMMARY: The results of Surveys (Health Inspections) have a significant impact on a Center's survival. This presentation will provide an overview of the LTC Survey and Post-Survey Process (Assignment of Citations, CMP's and other Enforcement Remedies).

During this session, we will discuss practical strategies to ensure Survey Readiness and to explore facility leaders' tasks and options in dealing with the aftermath of Survey Deficiencies (POC, IDR, IIDR, Appeals Process with the DAB, etc.).

SESSION: Medicaid Transition to PDPM -Leveraging Data and Technology for Case-Mix Management

SUMMARY: New York Medicaid is transitioning to PDPM for SNF rate setting. While rates are purportedly "frozen" until the new system is implemented, there is skepticism on whether our PDPM capture now will somehow impact Medicaid rates in the future. Providers can't take anything impacting Medicaid rates for granted, and many are acting now. This session will focus on operational strategies to establish effective interdisciplinary protocols to identify changes in resident acuity. The speakers will provide observations of the transitions to PDPM in other states, introduce early PDPM capture data from New York State providers and introduce benchmarks from other State Medicaid systems that have already transitioned to PDPM for attendees to compare their performance to. Lastly this session will demonstrate how to leverage technology to enhance clinical capabilities and management efficiency.

Included in this can't-miss session will be an overview of the new guidance of F605 (Psychotropics and Chemical Restraints); F658 (Schizophrenia Documentation Requirements), as well as how F756 (Consultant Pharmacist and Drug Regimen Review) and F841 (Medical Director's Role and Responsibilities) are wrapped into everything. Dr. Hallett will be providing useful handouts, tools, and compliance tips in the typical, lively fashion that NY-ACHCA audiences have come to expect, so get there early and be ready. SESSION: Behavioral Health: Addressing Mental Illness in LTC

SUMMARY: Learning Objectives:

- 1. Understand the symptoms and behaviors associated with a diagnosis of mental illness;
- 2. Explain the importance of distinguishing symptoms from reactions and personality; and
- 3. Cultivate a culturally competent, traumainformed workforce with the interest and motivation to ensure a person-centered, person-directed approach to resident care.

As the numbers of long-term care residents with mental illness increases, the education and training of the staff becomes vital to successfully managing the needs of this population. Unlike dementia, a diagnosis of schizophrenia, bipolar depression, obsessive compulsive disorder, or other chronic mental illness requires a working knowledge of the symptoms and how the disease impacts the individual.

This session is designed to provide basic, common sense information on these mental health challenges. The most effective avenues to assessment and care planning, as well as helping residents to find satisfaction and a quality of life in the management of their disease are central to this conversation.

Facilities must remain in compliance with not only the FTags (Health Inspection) but with KTags. These tags refer to NFPA 101 or, as it is more commonly referred, the Life Safety Code. This presentation will review the most commonly cited KTags and discuss strategies, tips and tools to avoid these deficiencies.
